- ! Monthly Fees are \$30.00 for an individual and \$45.00 for a family are due the 5th of each month

- ! Membership covers the primary member and immediate family members only. ***Immediate family members are defined as spouse or children under the age of 21 who reside in the same household.***

- ! ***EACH FAMILY MEMBER MUST SUBMIT AN APPLICATION BEFORE USING THE FACILITIES.***

- ! Checks should be payable to Wheeler County. If paying with cash, please place money in an envelope with a note including member name(s). Please indicate which month(s) the dues cover. Place dues in drop box or deliver to Tami Stockton at the Courthouse, 701 Adams St.

- ! Door code will change the afternoon of the 5th of each month. If the 5th falls on a weekend the code will be changed the following Monday.

- ! Guests are welcome but must join as members if they use the Center more than two times in one month.

- ! Children must be supervised at all times for the safety of all patrons. Children under the age of 14 are not allowed to utilize the equipment at any time.

- ! Exercise, or use of the equipment, must be attended by more than one person at all times.

- ! The cost for use of the Center for events other than established fitness programs is at a rate of \$50.00 per event.

- ! Proper fitness attire is required (ie - CLEAN gym shoes). NO boots, street shoes, sandals, or bare feet.

- ! No food or drinks, except water or sports drinks.

- ! Please return all equipment and weights to proper location.

- ! ***Please wipe down each piece of equipment after use.***

- ! If problems arise with facilities or equipment, please contact Tami Stockton at 541-763-2911

- ! Be sure all lights are turned off if you are the last person leaving the building.
