## EVENT TRAILER USE AGREEMENT

1. Borrower is certifying to the County that they are using an insured vehicle which is designed and intended to be used with a trailer. It is recommended the vehicle used to haul the trailer should be at least ¾ ton rated.
2. Borrower is certifying that the driver of the vehicle transporting the trailer is at least 18 years of age and has a valid driver's license.
3. Borrower is accepting the trailer in "as is" condition, the County makes no claims or warranties as to its condition at the time of borrowing, further Borrower certifies they have inspected the trailer, including but not limited to coupling, safety chains, wheels, tires, and lights, and found it to be safe operating condition. The Borrower waives all claims for any personal injury, property damage or losses arising out of the use of the trailer, or any accident or breakdown.
4. Borrower hereby agrees all equipment borrowed will be returned on time and in the condition, it was received. **Borrower will ensure that all tables and chairs used are properly cleaned and stored after their use.**
5. Borrower is responsible for all reasonable repairs or replacement should damage beyond normal wear and tear occur during the borrowing period.
6. Borrower agrees to hold the County harmless of all liability, losses, damages, costs, or expenses which arise out of the negligent act or omission of the Borrower arising out of the Borrower's use of the trailer, tables, or chairs.
7. Borrower will not use the trailer or equipment for anything other than the stated purpose/event.
8. Borrower will not loan the trailer or equipment to any other individual or organization.
9. Borrower certifies all equipment; borrower will always remain within the boundaries of Wheeler County.
10. It is recommended that two individuals operate the tables and chairs carts when unloading & loading them in/out of the trailer.
